## **AUDIT RESULTS**

#### Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

#### About the audit

This report contains the results of our independent accountability audit of Mason County Fire Protection District No. 18 from January 1, 2019 through December 31, 2021.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended December 31, 2021, 2020 and 2019, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Payroll gross wages and leave balances and accruals
- Self-insurance for unemployment
- Accounts payable employee scholarships
- Open public meetings compliance with minutes, meetings and executive session requirements
- Financial condition reviewing for indications of financial distress

## INFORMATION ABOUT THE DISTRICT

Mason County Fire Protection District No. 18 has served the Lake Cushman area of Mason County since 1977. Mason County Fire Protection District No. 1 served the members of Hoodsport from approximately 1941 until it merged into Mason County Fire Protection District No. 18 effective January 1, 2021. The District covers 29 square-miles and has a population of 2,600 to 20,000 depending on the time of year.

The District primarily consists of volunteer firefighters but does have a paid full-time fire chief, office manager, and firefighter/EMT. An elected, five-member Board of Commissioners governs the District. The District is funded primarily by property taxes. The District operated on revenues of about \$1.5 million, \$670,000 and \$480,000 in 2021, 2020 and 2019, respectively.
