#### **Old Business:**

Merger Challenges: Official date of Merger needs to be moved to January 1, 2026. District 17 will ask for a Levy Lid Lift in April 2025, and if approved will ask for request the Merger in August 2025. We would have a contract for services until January 1, 2026.

We will have our Town Hall Meeting regarding the merger February 1, 2025. We have created a mailer newsletter to send to the community. We will also have an open house that day to invite the community to walk through the stations, see the boat, etc.

Shawn Berry was selected as our "Temp Hire" for 2025.

Building Committee: have not met yet. Will need to meet with a general contractor to determine steps on how to move forward. Jim Goodpasture has offered to bring in any dirt we need. We anticipate approximately \$400,000.00 will be needed towards a building.

#### **New Business:**

Investments: Money was moved from Cash to Investment accounts to gain interest while it's not being used. Money will be moved back to cash accounts each month as the amount needed is determined by bills and payroll.

We submitted applications for two regional FEMA grants, two independent FEMA grants and three DNR grants.

GEMT: We signed a contract to participate in the program that helps offset the transport costs of Medicaid patients.

We currently have three students in the Mason County EMT course, we had one EMT to take the protocol test today.

Captain Menard: The fire ready program for the county is 1/9/2025. Thurston and Mason County have the highest wildland fire risk in Western Washington.
